

**CITY OF DUNDEE**

**ORDINANCE NO. 429-2005**

**AN ORDINANCE AMENDING ORDINANCE NO. 162 OF THE CITY OF DUNDEE, OREGON, ESTABLISHING AN APPROXIMATELY EQUAL EXPIRATION OF PLANNING COMMISSION TERMS EVERY TWO YEARS, AND AFFIRMING SUBSEQUENT TERM LENGTHS OF FOUR YEARS.**

**WHEREAS**, Ordinance No. 162 established the Planning Commission for the City of Dundee, Oregon; and

**WHEREAS**, Section 3 of Ordinance 162 created Planning Commission terms of four years, except that initial appointments of some members were for other specified terms so as to establish an approximately equal expiration of terms each year; and

**WHEREAS**, some Planning Commissioners did not serve full four year terms, and the resulting vacancies were not filled for the remainder of the unexpired terms but rather new appointments were made for full four year terms; and

**WHEREAS**, the approximately equal expiration of terms each year was lost as a result; and

**WHEREAS**, the City Council now desires to re-establish staggering terms with the approximately equal expiration of terms every two years; AND

**WHEREAS**, reappointment of some current Planning Commissioners is needed to re-establish the staggering of terms and establish the approximately equal expiration of terms every two years.

**NOW, THEREFORE, THE CITY OF DUNDEE DOES ORDAIN AS FOLLOWS:**

**SECTION 1.** Ordinance 162, Section 3, is hereby amended to read as follows:

Section 3. Appointment and Term. Members of the Planning Commission shall be appointed by the City Council for a term of four years except for appointments made for other specified terms in order to establish an approximately equal expiration of terms every two years.

**SECTION 2.** In order to implement Ordinance 162, Section 3, as amended, the terms of the following Planning Commissioners shall expire on December 31, 2005:

1. Debra Manning
2. Michael Sherwood
3. Forest Byerly

**SECTION 3.** In order to implement Ordinance 162, Section 3, as amended, the terms of the following Planning Commissioners shall expire on December 31, 2007.

4. Ron Mock
5. Larry Lietz
6. Ted Crawford
7. Maria Hinoveanu

**SECTION 4.** All subsequent Planning Commission terms shall be for a period of four years in order to comply with the intent of Ordinance 162, Section 3, as amended. Pursuant to Ordinance 162, Section 4, appointments to fill unexpired term vacancies shall only be for the remainder of the unexpired term. No appointments shall be made to fill an unexpired term vacancy for any period of time longer than the remainder of the unexpired term.
