

ORDINANCE NO. 2009-06-035

AN ORDINANCE RELATING TO THE 2009 BUDGET RECOGNIZING RECEIPT OF A FEDERAL GRANT TO THE PLANNING AND COMMUNITY DEVELOPMENT DEPARTMENT IN THE AMOUNT OF \$227,522.00 AND APPROPRIATING RELATED EXPENDITURES IN THE COMMUNITY DEVELOPMENT BLOCK GRANT FUND AND INCREASING THE GENERAL FUND ESTIMATED ENDING RESERVES.

WHEREAS, the City has been notified that it will receive supplemental Community Development Block Grant (CDBG-R) funds in the amount of \$227,522.00 under the American Recovery and Reinvestment Act (ARRA), and;

WHEREAS, the purposes of funds provided under ARRA are to stimulate the economy through measures to modernize the Nation's infrastructure, to improve energy efficiency, and to expand education opportunities and access to health care, and;

WHEREAS, the City plans to use the CDBG-R funds in conjunction with the Opportunity Council's weatherization funds in order to enhance energy conservation and efficiency, to assist those most likely to be impacted by the recession, and to create or preserve construction jobs hard hit by the decline in housing constructions and sales, and

WHEREAS, a portion of the grant funds will be used to reimburse the General Fund for administrative services provided by staff for this project,

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

1. The sum of \$227,522.00 is hereby appropriated in the Community Development Block Grant Fund. The source of funding will be credited from:




