

ORDINANCE NO. 2009-09-059

AN ORDINANCE RELATING TO THE 2009 BUDGET REALLOCATING \$12,440.00 IN EXPENDITURES IN THE POLICE DEPARTMENT, GENERAL FUND; AND THE PUBLIC WORKS DEPARTMENT, PARKING SERVICES FUND; TO ACCOMMODATE AN INCREASE IN SALARY AND BENEFIT COSTS RESULTING FROM A RENEGOTIATED WAGE LEVEL FOR PARKING ENFORCEMENT OFFICERS.

WHEREAS, the Human Resources Department received a job audit request for Police Department Parking Enforcement Officers, and;

WHEREAS, a significant ongoing job duty was added to the responsibilities for the classification beginning April 1, 2009, and;

WHEREAS, an agreement has been reached with the bargaining representative for the classification regarding the appropriate wage level for the modified position, and;

WHEREAS, the General Fund is fully reimbursed for the cost of Parking Control Officers by the Parking Services Fund.

NOW, THEREFORE, THE CITY OF BELLINGHAM DOES ORDAIN:

Section 1. Effective April 1, 2009 four positions of Parking Enforcement Officer, Plan B Grade 6, in the Police Department are hereby deleted. Effective April 1, 2009 four positions of Parking Enforcement Officer, Plan B Grade 9, are hereby created. There is no change in FTEs as a result of this upgrade. The source of funds will be credited from:


